Traffic Citations are tickets issued for traffic violations only.

“Arrests” includes all custodial arrests where the person(s) were taken to the jail facility. “Summons” is all non-custodial arrests: released at the scene with a summons (or penalty assessment ticket) to municipal or county court (non traffic violations).

“Warrants” are the number of warrants applied for where an arrest is pending.

“DUI” includes all driving offenses where alcohol or drugs were a factor in the violation.
