Recommendation

Staff sees no problem in approving this application for a Special Events Liquor Permit to Ducks Unlimited, Inc. for their event scheduled for March 6, 2010.

Background

Ducks Unlimited, Inc. has submitted an application for a Special Events Liquor Permit for a fund raising event at Bill Heddles Recreation Center on March 6, 2010. The application specifies that they plan to serve malt, vinous and spirituous liquor from 5:00 pm to 11:00 pm. The application is complete and the fees, \$35 to the City, and \$25.00 to the State, have been paid. A sign notifying the public of this hearing has been posted at the site for at least ten days as required by law. As of the writing of this memo, no comments either for or against the approval of the application have been received by the City Clerk.

Cost

There is no cost to the City.

Action to be Taken if Approved

The Mayor and Clerk will sign the application, and the Clerk will mail it to the State, who will review it and issue the permit.

I move to approve Ducks Unlimited, Inc.'s application for a special events liquor permit for March 6, 2010.
