





Dear Mr. Torgler,

Thank you for providing funding in 2016 for transportation for seniors and people with disabilities. Your contributions are making vitally needed transportation possible in Delta County. In January through September 2016, All Points Transit delivered 7,964 Dial A Ride trips in Delta County. This is a 10% growth year to date over 2015. Of the delivered trips in 2016, 44% were medical trips, 34% were for nutrition and 22% were personal trips.

All Points Transit has taken some recent initiatives to improve service for Delta County residents, including offering weekly shuttle options into Delta from outlying areas, collaborating with the medical clinics to form a medical shuttle schedule and pushing our latest medical appointment time back to 3:15pm from 2:00pm. We have received a lot of positive feedback and hope you are hearing good things from your residents, as well!

As discussed at the September 2016 Municipal Quarterly Meeting in Crawford, we are requesting funding for 2017 in the same amount as 2016 for Delta County and the municipalities. Your repeat funding will enable this essential transportation to continue next year. The City of Delta's contribution is \$17,318. Your full support is very much appreciated.

As always, I welcome your comments or suggestions. Do not hesitate to contact me if you need more information. As a new Executive Director, I look forward to working with you to serve Delta County residents. On behalf of our passengers, board of directors and staff - Thank you for your continued support of All Points Transit!
